### **President's Report: Brendan D'Angelo**

Brendan D'Angelo reported on Town Grants. Also mentioned great success of Virtual Dog Show, Select board Candidates Forum and Town meeting. Possible short film series this summer, if COVID situation improves. Suggested a Producer's Circle meeting to generate ideas on new shows and programming.

### **Director's Report: Paula Wehde**

Paula reported that WOA received \$325 from State of VT in unclaimed funds. Gracenote program guide will no longer be used, not viable for our station. Vimeo will be reduced from Business to Pro in July. School will be sharing their Hudl camera sports files with us. We will be filming graduation, and Alumni Day parade will be in Sept this year. Working on VAN annual report and budget. Davis McGraw suggests the "I am VT too" series which I have been playing. Have also been playing programs received by the Chickasaw Nation Paula reported that server is operating well, and able to stream meetings out simultaneously on all three platforms, channel, FB page, and website.
